## THEIAB=RNACLE IN THEWHLDERNESS

 Part 2: 'Let Them Make Me A Sanctuary' Continued..Reading: Exodus 25:1-9

## Introduction

- A sprawling camp of 600,000 tents covering a 6 to 8 square mile site.
- A rectangular structure right in the very centre of the camp surrounded by a white linen perimeter fence.
- We've considered
i) The PEOPLE
ii) the PATTERN
iii) the PURPOSE and
iv) the POSITIONING of the Tabernacle.


## 1 The Plan Of The Tabernacle

- The whole Tabernacle was made up of 3 parts:
- The Outer Court was rectangular in shape 100 cubits (north and south sides) X 50 cubits (east and west sides) ( 150 feet $X 75$ feet).
- The single entrance was in the east side and was 30 cubits wide.
- The court was home to the brazen altar and the laver.
- The 'Tabernacle' (God's Tent) was also rectangular: 30 cubits (length) X
- 10 cubits (width) and 10 cubits (height).
- The 1 st section called the 'Holy Place' was $20 \times 10 \times 10$ and was home to the 7 branched golden lampstand, the table of show bread and the altar of incense.
- The 2nd section called 'the Holy of Holies' was $10 \times 10 \times 10$ and housed the sacred ark of the covenant illuminated by the 'Shekinah' glory of God.
- Only the high priest could enter the Holy of Holies and then only once a year on the 'Day of Atonement.'
- NB. In the NT book of Hebrews there are some 303 references to the Tabernacle.


## 2 Tents, Tabernacles And Types

- The whole Tabernacle is a type/picture of Christ and His redemptive work.
- The Tabernacle was for God to dwell in among His people.
- [John $1: 14$ ] "the Word was made flesh and dwelt (Tabernacled) among us."
- It took 9 months to construct the Tabernacle. Christ was in Mary's womb for 9 months being prepared to 'tabernacle' among us.


## 3 The Significance Of The Fence

- Perimeter fence was 100 cubits X 50 cubits creating a consecrated space.
- The fence was composed of fine white linen.
- White linen symbolised holiness and righteousness which God is.
- This is a problem for fallen humanity because they are naturally sinful. [Romans 3:10].
- All our attempts at being righteousness are like filthy rags and far from white. [Isaiah 64:6].
- The fence is thus a barrier between me and God.


## 4 The Relevance Of The Gate

- The gate was 30 cubits wide and in the eastern side.
- It was the only way to God but it was wide enough that any and all could come.
- The gate section was blue and purple and scarlet in colour.
- The gate speaks of Christ. [John 10:9].
- The blue speaks of heaven where He came from, the purple indicates His royalty as King of kings and the scarlet speaks of the blood He shed.
- Gates of towns and cities in OT was where sin was judged, covenants were witnessed and prophets like Jeremiah called for repentance.


## Finally

- When Adam/Eve sinned they ran away from God in an easterly direction.
- They were evicted and cherubim posted on the east of the garden to prevent them re-entering.
- They moved from the west to the east.
- God reverses this at the Tabernacle: the worshipper comes from the east and moves west to where God is in the Holy of Holies.
